ORDER ASSESSING AN ADMINISTRATIVE FINE UNTIL COMPLIANCE IS ACHIEVED

This case was heard at a public hearing before the Special Master on May 27, 2009. *q.cgw*

The Petitioner, City of Jacksonville appeared and was represented by Inspector Donald Douglas of the Property Safety Division.

The Respondent, Queenie Brown, did not appear.

Findings of Fact

Based upon the evidence and sworn testimony received, the Special Master finds the following:

1. That Queenie Brown is the owner of record of the subject property at issue herein, which is located at 27 East 32nd Street, Duval County, FL, RE No. 133358 0000.
2. That notice of this hearing was mailed to Queenie Brown, as record owner of this property on April 21, 2009.
3. The subject property was initially inspected on September 26, 2008, and was reinspected on May 26, 2009.
4. That the property located at 27 East 32nd Street, Duval County, Jacksonville, Florida contains the deficiencies as listed in the Statement of Violation and Request for Hearing dated December 16 2008, which is incorporated in this Order by reference.
5. That previous notification of the aforementioned deficiencies was given as supported by the evidence received by the Special Master.

Conclusions of Law

That the said property is in violation of the Jacksonville Ordinance Code provisions listed in the aforesaid Statement of Violation and Request for Hearing.

It is ordered: (1) the Respondent must immediately correct the violations as aforementioned and (2) the Respondent is assessed an administrative fine in the amount of \$250.00 per day, effective May 27, 200~~8~~⁹, until such time as the violations are corrected.

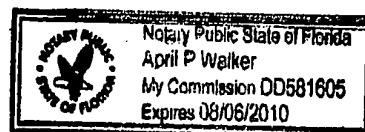
